**RV LOT Vehicle Storage:** 2026 dues for stored vehicles are due January 1st. You might check if you're set up for automatic payment which should come out on 1/1/2026. The annual fee is paid upfront, and any changes during the year are refunded on a prorated basis.

**Republic Services:** 2026 is here! On your Republic calendar, Edgewood **recycle week is "B"**. Peruse your Republic Services calendar for all types of information and tips on recycling.

Recycle your fresh Christmas tree on **January 5th or 12th** by placing it next to your green waste bin on collection day.

Thanks for making sure your cans are pushed out from your garage gutter so when the can is picked up it doesn't do damage to the gutter.

**Motorized Scooters:** Did Santa provide any bikes or motorized scooters for Christmas? If so, here is some information on riding them.

- California law states a helmet must be worn if the rider is under the age of 18.
- Speed limit in Edgewood on the side streets (where garages are accessed) is 5 MPH.
- Speed limit on Spyglass is 15 MPH.
- Bicycles or scooters are prohibited on the sidewalks.

**Pets:** HOA rules allow up to two pets per residence. County and City rules require dogs

to be leashed (max 8 feet) unless at a designated dog park. Thank you for ensuring your pet is leashed and poop is picked up when taking them out into the common areas of Edgewood.

**Parking:** The streets (commonly referred to as alleys) whereby you access your garage are fire lanes and must remain clear of vehicles in case of an emergency. If you need to park in front of your garage, please ensure it is for a very brief period. The vehicle should not be left unattended in case of such an emergency.

Guest parking at Edgewood is limited and reserved for guests. For residents, temporary parking for loading and unloading is fine, but long-term, regular parking is not.
